ENTRY DEADLINE: July 1, 2010

ENTRY PROCEDURE:

- No Entry Fee. Artists ages 7 - 21 from the United States may each enter one original work.
- Attach a label to the back of the artwork with the artist's name, address, age, and title of the artwork.
- Mail entries to: LD Art, c/o Boone Mall, 1180 Blowing Rock Rd., Boone, NC 28607

MEDIA: Original two-dimensional works of art, matted or unmatted.

No framed works, photographs, computer art, sculpture, cartoon or comics characters, copies or glitter.

SIZE STIPULATIONS:

- Pictures with mattes: Mattes no larger than 24" x 28".
- Pictures without mattes: Must be on paper of one of these sizes: 8½" x 11" or 11" x 17".
- Stretched canvas: No larger than 20" x 30" Edges must be painted.

AWARDS: Twenty artists will receive \$50 awards for artwork showing special artistic merit.

Ten artists from the local area will also receive \$25 Local Artist awards.

Artists who offer their artwork for sale will receive 100% of the purchase price.
